About LSETF/PTI PROJECT

PTI and LSETF intend to work together under the **LSETF-PTI Employment Support Project** to fund a series of employability programmes (Get Into, Get Hired and Get Ready), the **Programmes** to be delivered in Lagos State by delivery partners under license from PTI with the aim of tackling youth unemployment by supporting young people with the skills and experience to move into sustainable work, self-employment or further education and training ("**Project**").

Lagos State Employment Trust Fund (LSETF) was established to provide financial support to residents of Lagos State, for job, wealth creation and to tackle unemployment. LSETF serves as an instrument to inspire the creative and innovative energies of all Lagos residents and reduce unemployment across the State. The Fund has the mandate to help Lagos residents grow and scale their Micro Small and Medium Enterprises ("MSMEs") or acquire skills to get better jobs through its three programmes; the Employability Support Programme, the Lagos Innovates Programme and the Loan Programme.

Prince's Trust International (PTI) has been supporting young people worldwide since 2015. PTI was founded by His Majesty King Charles III, to tackle the global crisis in youth unemployment, building on four decades of experience in the UK. Prince's Trust International has been supporting young people worldwide and now works with partners in 18 countries within the Commonwealth and beyond, across Africa, Asia, the Caribbean, the Middle East and Europe. Prince's Trust International partners with local organisations to deliver education, employment and enterprise programmes that support young people into sustainable careers. This role will be responsible for supporting in the implementation of the LSETF-PTI Employability Support Project. The role will involve working closely with partner organizations and stakeholders, implementing detailed implementation plans and associated project management tools, conducting employer, young people and stakeholder engagement activities and reviews, and supporting other projects/initiatives across the State as necessary.

The successful candidate will be a resilient, enthusiastic, self-starter with a strong understanding of the challenges facing programming for young people and the ability to work with partners to deliver results under challenging and varied circumstances. The project officer will have strong planning and organizational skills and the ability to work with people from different countries in the public, private and voluntary sectors, with evidence of their ability to influence and secure sustainable results. The officer will have enthusiasm and passion for PTI and LSETF's vision and a conviction to deliver high positive outcomes for young people. Project Implementation and Delivery Partner Management	 Support the implementation of the LSETF/PTI Employability Support Project, particularly the Get Into/Get Hired and Get Ready programmes, ensuring their safe delivery at quality standards. Directly manage and monitor ongoing delivery of programmes, supporting in-country partners to meet agreed targets, and reporting on progress to LSETF and PTI. This may include supporting in delivering training and producing toolkits and resources. With specific responsibility for growing, developing and enhancing the impact of programmes in Lagos. Oversee partner activity including youth engagement and screening, employer engagement, programme commencement, placements, virtual delivery, programme events (job fairs) Analyse relevant partner documents and key performance indicators such as attendance reports, project milestones, stipend schedules for young people Maintain and periodically update database of all enrolled and placed students. Support partners to Identify and update curricula with new training areas in line with Industry demand where necessary. Drive placement of certified students through the LSETF dedicated tools (portal, website, directory, etc.) to relevant stakeholders. Oversee the database of all young people enrolled onto the programme. Attend all key programmatic events including taster days, graduation events.
Finance	 Monitor and review delivery partner finances, including reviewing expenses and receipts against budget, invoices etc. Ensure accurate and up to date financial reporting for internal and external purposes, including creating finance reports each quarter ahead of the Project Committee meetings. Lead on LSETF's procurement process for making payments to partners, ensuring all documents are collected from partners and submitted within a timely manner.
Employer and Stakeholder Management	 Support with industry and employer engagement activities such as managing employer requests for trainees, employer and job mapping, employer interviews and follow-ups, gaining feedback on programme and participants. Support the PTI Country Manager, where required, by representing the Project team at events and meetings. Support the PTI and LSETF teams where required to manage communication and relationships with external partners, supporters, key stakeholders and interested parties where required.
